Such profile shall be submitted to the Returning Officer as a Microsoft Word document by email.

Only Informational Profiles which comply with the Rules and are received by the Returning Officer by 12:00 noon (Australian Eastern Daylight Time (AEDT)) on 26/02/2024 can be accepted.
