#### **Candidate Statements**

Candidates may submit complete an "Information Profile" in support of their candidature. Such a profile shall be no more than 200 words in length and shall only include the candidate's name, location, region, work or Association experience, reason for nominating; or other relevant information which could assist the voter in their decision. Only statements which comply with the Rules and are received by the Returning Officer by 5pm Australian Eastern Daylight Time (AEDT) on 17/02/2023 can be accepted.

The appointment of scrutineers opens on 03/02/2023 and closes 10am Australian Eastern Daylight Time (AEDT) on 05/04/2023. A Scrutineer Appointment form is available from the Returning Officer.
