### **Withdrawing Nominations**

Nominations cannot be withdrawn after 5pm Australian Eastern Daylight Time (AEDT) on 17/02/2023.

#### **Candidate Statements**

Candidates may submit an "Information Profile" in support of their candidature, which shall be no more than 200 words in length and shall only include the candidate's name, location, region, work or Association experience, reason for nominating; or other relevant information which could assist the voter in their decision. This will be included with ballot material. Only statements which comply with the Rules and are received by the Returning Officer by 5pm Australian Eastern Daylight Time (AEDT) on 17/02/2023 can be accepted.

#### **Voting Period**

The ballot, if required, will open on 08/03/2023 and close at 10am Australian Eastern Daylight Time (AEDT) on 05/04/2023.

## **Scrutineers**

The appointment of scrutineers opens 03/02/2023 and closes at 10am Australian Eastern Daylight Time (AEDT) on 05/04/2023. A form is available from the Returning Officer for the purposes of appointing Scrutineers.
